1. Regular Scheme:-

- One time registration fee Rs.200/-.
- Rental Rs.10/- per hour or part thereof.
- Minimum recharge Rs. 300/-.
- **Cycle has to be returned back before closing time.**
- Rs.100/- shall be charged if cycle kept overnight (an advance intimation is necessary)
- Rs. 4000/- shall be payable in case of loss of bicycle.

***Service Tax extra as applicable.**

2. OWNBYK Scheme:-

- One time registration fee Rs.200/-.
- Refundable deposit of Rs.4000/-.
- Rs.300/- per month towards **unlimited usage.**
- **Member can keep the bicycle overnight.**

OWNBYK Membership Scheme has 6 months lock in period during which membership cannot be surrender.

Terms and Conditions:

1. (a) Please fill the registration form and deposit with ID & Address proof copies at any of our cycle shelter.
(b) Online registration form is also available on our website: www.greenolution.in
(c) The applicant can also register through our mobile app "LetUsCycle".
2. Greenolution Smart Card is optional as members can book the cycles easily via our mobile app and through their smart phones at any of our cycle shelters.
3. Advance blocking of bicycle facility is available to members to ensure availability. But they have the option to take the cycle from cycle shelters without any advance booking.
4. Cycle Issue and Deposit should be done with Attendant at designated Cycle Shelter only. Depositing cycle elsewhere will be responsibility of Commuter.
5. Only one cycle will be issued against one card.
6. Any damages to the cycle will be borne by the commuter.
7. Any change in address should be informed to M/S Greenolution.
8. Validity of smart card will be one year from the date of issue.
9. All disputes are subject to Delhi Jurisdiction.
10. The company is neither responsible nor liable to pay any compensation in case of any accident/untoward incident.
11. As soon as a cycle is issued to a card holder, a Welcome SMS shall be sent to the registered mobile number. Similarly a Thank You SMS shall be sent at the time of deposit of a cycle.
12. On demand we shall issue a Greenolution Smart Card with QR Code against payment of Rs. 50/-.
13. M/S Greenolution reserves the right to change terms and conditions from time to time without prior intimation.

14. For Regular Member:-

- a. FIR or Legal action shall be initiated in case cycle is not returned within stipulated time. Action can be also taken against the references furnished by the member.
- b. In case the uploaded documents are found to be inadequate/fake, the membership shall be cancelled and advance paid (not registration fee) shall be refunded.

15. For Visitor:-

- a. FIR/legal action shall be initiated if cycle not returned in 24 hours.
